



3. Tenders received after due date and time will not be considered.
4. The bidder shall submit bid security @2% of the bid cost in the form of CDR, both electronically along with the E-bid and in hard copy before the closing time, as specified in the bidding documents. The CDR must be in the name of the District & Sessions Judge, Kolai Pallas Kohistan.
5. The successful bidder shall submit a 10% performance guarantee of the total contract amount and execute a contract agreement in accordance with the Khyber Pakhtunkhwa Public Procurement of Goods, Works & Services Rules, 2014.
6. Incomplete, ambiguous and conditional or below specification bids shall not be entertained.
7. The firm/vendor should be registered with Sales Tax and Income Tax Department, KP-PRA and FBR, having valid NTN and active Tax payer. Valid documents of the above must be uploaded with documents.
8. The successful bidder will be strictly bound to supply the items according to specifications within stipulated period after the issuance of supply order. Failure in supply within stipulated period or below specifications shall entail in cancellation of that bid & forfeiture of the Earnest Money/Call Deposit Return (CDR) & in case of cancellation of supply order, new supply order will be issued to next lowest bidder.
9. The successful bidder shall provide the items as per Quality and Specifications mentioned in bidding documents or better than that.

**INSTRUCTIONS TO BIDDERS:**

1. Any information about the tender or standard bidding documents can be obtained from Office of the District & Sessions Judge, Kolai Pallas at Besham during office hour before the date of tender opening, KPPRA Website or downloaded from the official website [www.dsckolaiपालas.gov.pk](http://www.dsckolaiपालas.gov.pk).
2. This Bidding procedure will be conducted in light of Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) 2014.
3. 2% of total bid amount as Earnest Money/security deposit should be attached with the tenders, in the shape of Call Deposit, in favour of District & Sessions Judge Kolai Pallas. Tenders with Cross Cheque/ Banker's Cheque, demand draft and without call deposit shall not be entertained. The Earnest Money of the unsuccessful bidders, however, shall be returned after approval/finalization of the tender.
4. The bidders should submit their E-bids wherein last date of submission of E-bids is 30.04.2026 at 12:00, Noon which will be displayed on online EPAD system on 30.04.2026 at 1:30 PM in the presence of bidder or their representatives.
5. Tenders received after due date and time will not be considered
6. All the bidders are required to provide complete requisite documents i.e. PEC, NTN, FBR, KPPRA registration copies in Financial envelop for their eligibility, financial evaluation / Qualification as prescribed under the rules.
7. **The bid security/earnest money may be forfeited:**
  - a) In the case of a successful bidder failing to sign the contract or supply the equipment within the specified delivery time period.
10. **The procuring entity shall disqualify a supplier or contractor if it finds, at any time;**
  - b) That the information submitted by him concerning his qualification as supplier or contractor was false and materially inaccurate or incomplete.
11. No erasing / cutting etc. shall be allowed on the offer; such erasing/cutting etc. will lead to

- rejection of offer.
12. Price quoted must be in Pak Rupees and must include all applicable taxes. If not specifically mentioned in the tender/quotation, it will be presumed that the price includes all the Government Taxes.
  13. Supplier shall entirely be responsible for all taxes, duties, license fees etc incurred until delivery of the contracted goods to the Procuring Agency.
  14. Firms shall give warranty with parts and After Sale Services for the equipment they offer.
  15. Installation of equipment shall be the responsibility of successful bidder.
  16. In case, even if after delivery, the technical committee found the items/equipment defective, low quality, not working properly, or any other fault, the competent authority has the right to return the defective items/equipment for replacement or may award the bid to the next lower bidder after cancellation of his supply order.
  17. The Authority reserves the right to increase/decrease, reject any or all tenders with cogent reasons.
  18. Incomplete, ambiguous, and conditional bids shall not be entertained.
  19. The bidders must submit the proposal through EPADs and as per specified procurement method Single Stage Single Envelops Process.
  20. Disputes will be settled by the Grievance Redressal Committee mechanism as per section 35 of KPPRA Act 2012 and GRC Rules 2017.

**ELIGIBILITY CRITERIA:**

Bidders must give compliance to the below mentioned clauses as these are mandatory to being eligible for the bidding process. Relevant certificates must be attached.

- ✓ The bidder must be registered with Income / Sales Tax Department / NTN as per prevailing latest tax rules.
  - ✓ The bidder must provide proof of inclusion in the Active Taxpayer List (ATL) for both Sales Tax and Income Tax.
  - ✓ The bidder must have PEC Registration (Active) with Solar Code in case of Solarization.
  - ✓ The bidder shall provide an undertaking that the bidder has never been declared as black listed in past by any institution duly attested by Oath Commissioner/Notary public.
  - ✓ Bidders shall not be eligible to bid if they are under a declaration of Ineligibility for corrupt and fraudulent practices issued by any government organization.
  - ✓ If the bidder provides details concerning his qualifications as false/incorrect or incomplete, the legal proceedings shall be initiated against him.




